### **AGENDA HEADING:**

Approving Change Order No. 4 with E & H Restoration, LLC for additional work on 2017 Parking Garage Repair Program in the amount of \$94,132.96.

# **SYNOPSIS:**

Recommend approval of Change Order No. 4 with E & H Restoration, LLC, Mark F. Emde, President, 1926 Comenitz Drive, Davenport, IA, 52802, for additional work on 2017 Parking Garage Repair Program, in an amount not to exceed \$94,132.96.

## **FISCAL IMPACT:**

Amount: \$94,132.96

<u>Funding Source</u>: 2017-2018 Capital Improvement Program (CIP), Page Parking – 4, Parking Facility Rehab/Repair Program, PG016, Parking System Revenue

## ADDITIONAL INFORMATION:

- On June 26, 2017, by Roll Call No. 17-1126 City Council approved plans, specifications, form of contract documents and Engineer's estimate and designated the lowest responsible bidder for 2017 Parking Garage Repair Program as E & H Restoration, LLC in the amount of \$508,849. This project consists of structural repairs, fireproof patching, steel beam painting, joint replacement, sidewalk replacement, concrete deck sealing, and joint sealing in the 5<sup>th</sup> & Keo and 9<sup>th</sup> & Locust parking garages.
- During removal of the coating of the 5<sup>th</sup> & Keo garage, additional areas of partial depth concrete repairs on the deck surface were encountered.
- Additional work under Change Order No. 1 included:
  - o Additional partial depth floor slab repair (\$24,882.50).
- Additional work under Change Order No. 2 included:
  - o Additional repair due to corrosion of existing steel (\$117,959.75).
- Additional work under Change Order No. 3 included:
  - o Additional sidewalk removal and replacement (\$24,985.50).

- Additional work under this change order No. 4 includes:
  - Additional partial depth floor slab repair required due to excessive corrosion of the reinforcing in the slabs of the structure.
  - Additional full depth floor slab repairs required due to excessive corrosion of the reinforcing in the slabs of the structure.
  - o Additional traffic coating to cover the additional slab repair quantities.
  - Additional sidewalk repair at both parking garages.
  - Ouantity adjustments for as-built measurements.
