AGENDA HEADING:

Approving the purchase of Hewlett Packard, Inc., (10801 Farnam Drive, Omaha, NE, 68154, Dion Weisler, President) computer equipment using contracts established by the State of Iowa General Services or Department of Transportation contracts which has been competitively bid.

SYNOPSIS:

Recommend approval for the Information Technology (IT) Department to purchase computers from Hewlett Packard for replacement of outdated computers using State of Iowa contract pricing. This continues the computer replacement process in order to bring equipment up to date and keeps the City network secure. The Procurement Administrator has determined that the pricing has been competitively bid and is available to the City via State of Iowa Contract 16055A.

Amount: \$50,000

ADDITIONAL INFORMATION:

- This approval will allow the IT Department to use budgeted funding to continue to replace outdated computer equipment throughout City departments. The City will utilize the State of Iowa pricing agreement for Hewlett Packard equipment.
- Municipal Code section 2-726(f) provides for the procurement of goods and/or services from contracts that have been competitively established through the State of Iowa General Services or Department of Transportation and other cooperative contracting consortiums for state government departments, institutions, agencies and political subdivisions.
