AGENDA HEADING:

Amendment to the noise control ordnance to allow sound permits for large privately held recreational venues.

SYNOPSIS:

The ordinance amendment will allow outside commercial venues with an area of more than 40 acres to be granted a sound permit for outside events.

- The permit would allow up to eight (8) events in a 30-day period.
- The sound would be limited to 100 dBC's when measured 50 feet from the sound equipment.
- The permit would be effective between the hours of 9:00 a.m. to 11:00 p.m. Sunday through Thursday and 9:00 a.m. to 12:30 a.m. on Friday and Saturday, the Sunday of Memorial Day weekend, the Sunday of Labor Day weekend, and the Fourth of July whenever it occurs on a Sunday.
- The sound stage would need to face away from the residential areas.

This permit type matches a Type "A" Permit.

This amendment will allow Sleepy Hollow to have outdoor concert events.
