The Traffic and Transportation Division of the Engineering Department requested the Finance Department, Procurement Division, purchase traffic paint. Municipal Code Section 2-726(k) provides for the purchase of goods or services from contracts established by the State of Iowa Department of General Services, the IDOT, and the Iowa Communications Network, pursuant to procedures established by Chapter 8A Code of Iowa rules and regulations promulgated thereunder, without conforming to the competitive bidding requirements of the Purchasing Division.
