AGENDA HEADING:

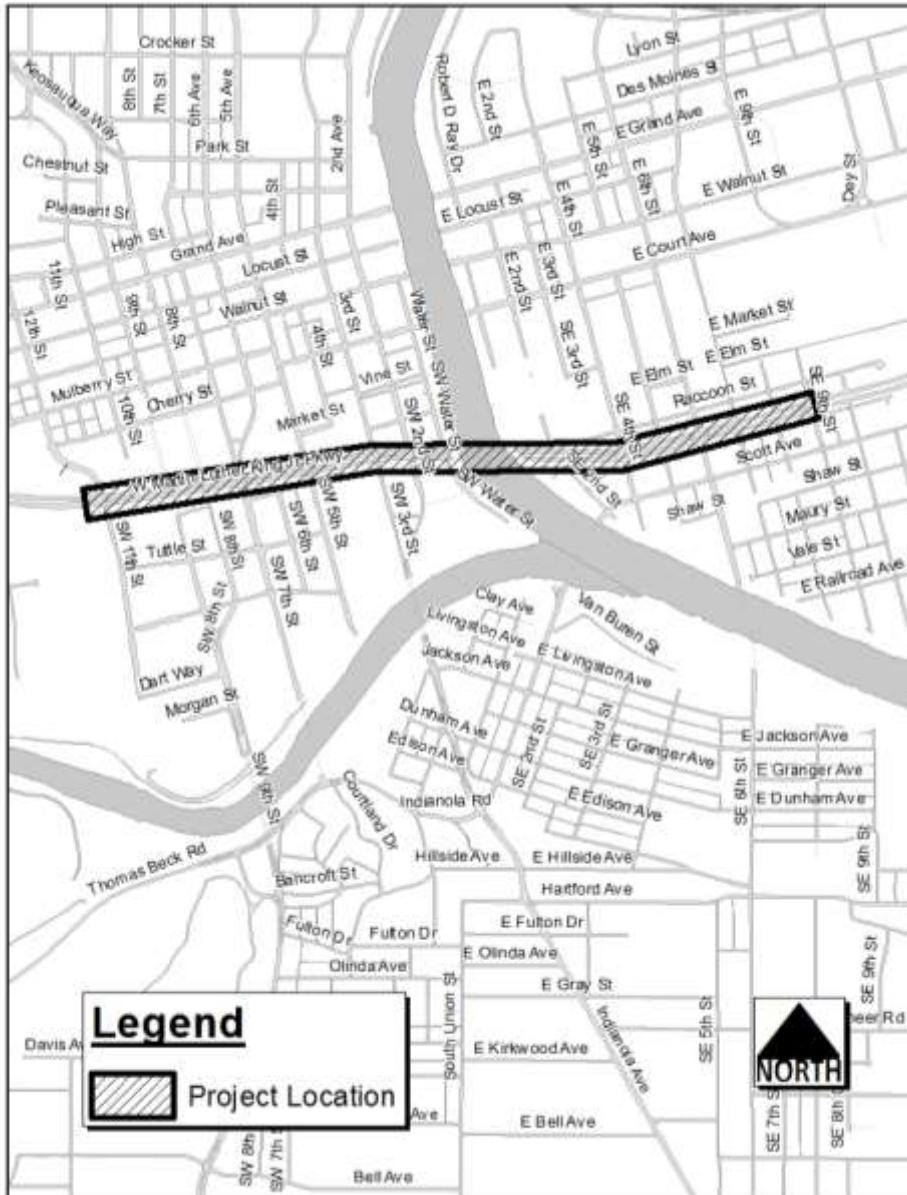

- On January 8, 2018, under Roll Call No. 18-0013, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2018 Martin Luther King Jr. Parkway Streetlights Upgrade. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2018 Martin Luther King Jr. Parkway Streetlights Upgrade, 04-2018-007.
