AGENDA HEADING:

Hearing on E. 42nd Street and Hubbell Avenue Intersection Improvements: Resolution approving plans, specifications, form of contract documents, engineer’s estimate, receive and file bids, and designating lowest responsible bidder as Absolute Concrete Construction, Inc., Matt Triggs, President, \$1,169,224.88.

SYNOPSIS:

This is a public hearing to allow for public input on the E. 42nd Street and Hubbell Avenue Intersection Improvements and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project is a traffic safety project which includes installation of a traffic signal and widening of the intersection at E. 42nd Street and Hubbell Avenue. This will increase traffic capacity and improve safety of this intersection.

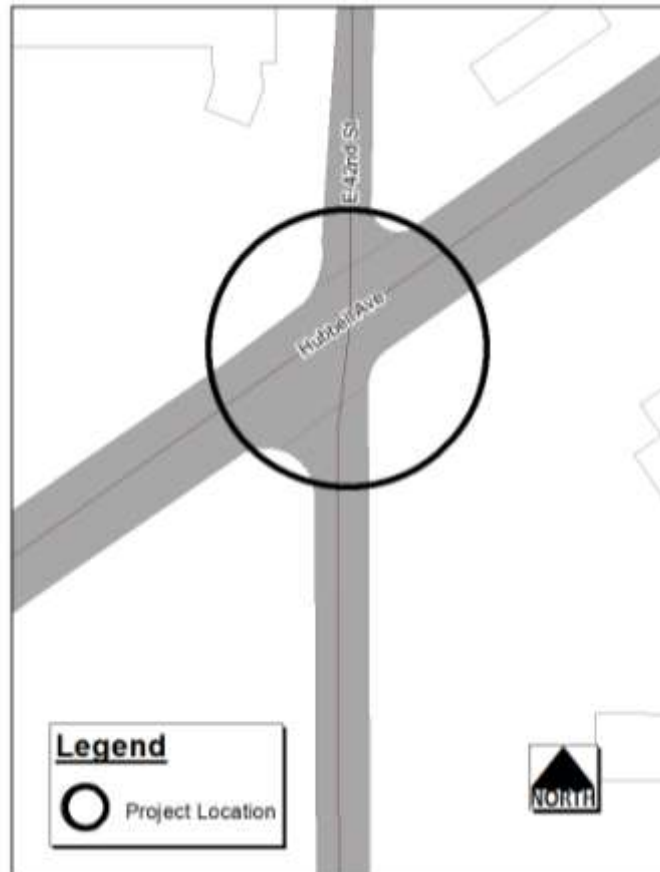
- On January 8, 2018, under Roll Call No. 18-0014, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the E. 42nd Street and Hubbell Avenue Intersection Improvements. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the E. 42nd Street and Hubbell Avenue Intersection Improvements, 06-2016-001. The improvement includes widening of the intersection of E. 42nd Street and Hubbell Avenue to include left turn lanes on Hubbell Avenue and the south leg of E. 42nd Street, installation of traffic signals, pavement removal, excavation, storm sewer intakes, subdrain, subbase placement, driveways, sidewalks, seeding, and miscellaneous associated work including cleanup; in accordance with the contract documents,

including Plan File Nos. 588-206/289, at the intersection of E. 42nd Street and Hubbell Avenue, Des Moines, Iowa.
