Derek Huxford (R-0) Patrol K9 Handler, to Evansville, IN from April 1 – May 12, 2018 to attend the Top Dogs Police K9 Academy. This training is conducted where the City's new K9 and all previous K9's have been procured. It is nationally known for instruction as well as the selection of the K9's.

Joseph Leo (R-0) Lieutenant, to Las Vegas, NV from April 29 – May 4, 2018 to attend the Americans for Effective Law Enforcement's Use of Force workshop. This training will assist in ensuring we are providing the latest information in training methods and rends, minimizing litigation and liability concerns, and conducting use of force investigations.
