Conditionally approving Birdland Vista Final Plat.


SYNOPSIS:

Recommend conditional approval of Birdland Vista Final Plat, located in the vicinity of 2426 Saylor Road, subject to completion of the required legal documents, and approval of the same by the City Legal Department. The subject property is owned by Greater Des Moines Habitat for Humanity, Inc., and is to be developed by Greater Des Moines Habitat for Humanity, Inc., 2200 East Euclid Avenue, Des Moines, IA 50317, Lance Henning, Officer.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

- Birdland Vista, located near 2426 Saylor Road, comprises approximately 3.69-acres on property that is zoned Planned Unit Development (PUD). The proposed development will consist of 23 single-family residential dwellings on 23 lots accessed 22-foot wide segments of right-of-way or street frontage.
- This plat is recommended for conditional approval to allow additional time for the receipt of revised legal documents to the satisfaction of the City Legal Department. The conditional approval is valid for a period of 30 days, upon which time reaffirmation of the approval would be required prior to recording the plat.
