AGENDA HEADING:

ADDITIONAL INFORMATION:

- Foth Infrastructure and Environment, LLC, was one (1) of the firms selected in September 2015 to perform 2016-2017 On-Call Traffic Engineering Services for the City. Staff negotiated a PSA with Foth Infrastructure and Environment, LLC, for a total cost not to exceed \$31,000, based on hourly rates, to provide 63rd Street and Creston Avenue Traffic Signals design services. On January 9, 2017, by Roll Call No. 17-0010, the City and Foth Infrastructure and Environment, LLC entered into a Professional Services Agreement for design services.
- On August 14, 2017, by Roll Call No. 17-1430, Iowa Signal was awarded the construction contract to place new traffic signals at 63rd Street and Creston Avenue.
- Supplemental Agreement No. 1 to the PSA with Foth Infrastructure and Environment, LLC provides for construction services for 63rd Street and Creston Avenue Traffic Signals.
- City staff has negotiated Supplemental Agreement No. 1 to the Agreement for Professional Services with Foth Infrastructure and Environment, LLC, for an additional amount not to exceed \$14,300, based on hourly rates, to provide construction phase services for the 63rd Street and Creston Avenue Traffic Signals project.
