## **SYNOPSIS:**

On January 12, 2018, the City accepted proposals for a redevelopment web presence to improve the City's website user experience with enhanced design, structure, content and functionality. Six (6) proposals were received and were scored by a cross-departmental selection committee. Based on the scoring, the selection committee recommends the award to Revize.

## FISCAL IMPACT:

<u>Amount</u>: \$332,500 Estimated 5-Year Cost. This is a five (5) year agreement with the estimates by year as noted below.
