AGENDA HEADING:

Hearing on 2018 City-wide Portland Cement Concrete (PCC) Pavement Restoration Program: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as MPS Engineers, P.C. d/b/a Kingston Services, P.C., Umesh G.Shetye, President, \$521,945.

SYNOPSIS:

This is a public hearing to allow for public input on the 2018 City-wide PCC Pavement Restoration Program and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for timely maintenance of PCC residential and arterial streets utilizing full depth removal and replacement of distressed panels to improve the surface condition and extend the useful life of the streets. The contractor will work jointly with the Public Works Department for the PCC pavement replacement.

FISCAL IMPACT:

<u>Amount</u>: \$521,945 Construction Contract (\$570,000 City Engineer's Estimate)

<u>Funding Source</u>: 2018-2019 CIP, Page Street - 8, Concrete Paving Restoration Program - Public Works, ST102, Being: \$281,850.30 in G.O. Bonds to be issued; and the remaining \$240,094.70 in G.O. Bonds transferred from ST205.

ADDITIONAL INFORMATION:

• On March 19, 2018, under Roll Call No. 18-0434, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2018 City-wide PCC Pavement Restoration Program. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2018 City-wide PCC Pavement Restoration Program, 06-2018-007. The improvement includes drilling, doweling, furnishing, placing, curing, sawing, and sealing PCC pavement patches of various thickness in a cooperative effort with the City of Des Moines, Public Works Department, at the following locations in Des Moines, Iowa:


