#### **AGENDA HEADING:**

Hearing on 2018 Americans with Disabilities Act (ADA) Sidewalk Ramp Program - Contract 1: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Ti-Zack Concrete, Inc., Steve J. Rutt, President, \$845,320.

#### **SYNOPSIS:**

This is a public hearing to allow for public input on the 2018 ADA Sidewalk Ramp Program - Contract 1 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the installation of new sidewalk ramps where required and the reconstruction of existing sidewalk ramps to bring them into compliance with ADA. The ramps will be constructed throughout the City at the highest priority locations included in the Phase III (Curb Ramps) Transition Plan approved by the City Council by Roll Call No. 09-2124 on November 23, 2009, and at locations required under Project Civic Access.


## **ADDITIONAL INFORMATION:**

• On April 9, 2018, under Roll Call No. 18-0548, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2018 ADA Sidewalk Ramp Program - Contract 1. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2018 ADA Sidewalk Ramp Program - Contract 1, 09-2018-002. The improvement includes construction of sidewalk ramps with Portland Cement Concrete (PCC) sidewalk four (4) inches, six (6) inches or eight (8) inches thick, together with all necessary appurtenances; in accordance with the contract documents, at various locations determined by the "Americans with Disabilities Act, City of Des Moines, Iowa, Transition Plan" throughout the City of Des Moines, Iowa.

• Sealed bids for said improvement were submitted by the following bidders:

Ti-Zack Concrete, Inc., Le Center, MN MPS Engineers, P.C. d/b/a Kingston Services, P.C., Des Moines, IA Hawkeye Paving Corporation, Bettendorf, IA TK Concrete, Inc., Pella, IA, - Bid not read – Proposal missing pages

- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on April 24, 2018.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Ti-Zack Concrete, Inc., Steve J. Rutt, President, 39352 221<sup>st</sup> Avenue, Le Center, MN, 56057 in the amount of \$845,320, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
