#### **AGENDA HEADING:**

Amending Chapter 102 of the Municipal Code to allow Vehicle Impact Protection Devices (VIPD) as an encroachment.

#### **SYNOPSIS:**

Recommend approval of the ordinance revisions to allow VIPD in the border area for crowd protection around event venues with a seating capacity of 2,500 or more.

#### FISCAL IMPACT: NONE

#### ADDITIONAL INFORMATION:

- Concerns have been raised regarding vehicle ramming type of incidents occurring with increased regularity around the world.
- Large event venues approached City staff about the possibility of allowing VIPD in the border area for the protection of those large crowds entering and/or gathering on public property adjacent to the event venue.
- The proposed ordinance would authorize the City Engineer to license the installation of VIPD in the border area adjacent to event venues with a seating capacity of 2,500 or more and that otherwise meet the terms of the Municipal Code.
- Allows for different types of VIPD, which are devices that are designed, engineered, and
  located to effectively separate areas of pedestrian and vehicular travel and prevent vehicles
  from entering areas which are solely intended for pedestrian use and travel. VIPD shall be
  comprised of bollards or barriers, or a combination of both.
- Sidewalks should be open and accessible to pedestrians to the greatest extent possible, and VIPD should minimize interference with pedestrian circulation, particularly in crowded locations.
- The proposed ordinance changes to Section 102-596 to Section 102-615 address the design, installation, location, size, spacing, color and height of all VIPD within the border area.

• On this same City Council Agenda, City Council is being asked to consider a license agreement with Des Moines Performing Arts to allow for VIPD within the border area along 3<sup>rd</sup> Street and Locust Street in accordance with the recommended ordinance revisions.
