AGENDA HEADING:

Hearing on Tower and Sheridan Park Restrooms; rejection of all bids on Tower and Sheridan Park Restrooms; and close public hearing on plans, specifications, form of contract documents, engineer's estimate.

SYNOPSIS:

Recommend the City Council reject all bids, because only (2) two bids were submitted, and only one (1) of the two (2) bids could be read, and the bid exceeded the estimate by 31%. In a recent public survey of the City's park system, the quality of the restroom facilities was cited as a need in the park system. Two (2) restroom styles were developed to be used throughout the City; a single stall restroom for neighborhood sized parks and a multi-stall restroom for larger parks. This project would have constructed a smaller restroom facility in Sheridan Park, and a larger restroom facility in Tower Park.



ADDITIONAL INFORMATION:

• On April 23, 2018, under Roll Call No. 18-0667, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Tower and Sheridan Park Restrooms. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Tower and Sheridan Park Restrooms, 11-2018-008. The improvement includes the construction of a new 500-square-foot restroom building at Tower Park and a new 220-square-foot restroom building at Sheridan Park; including limited site work preparation, foundation excavation, new concrete foundations, concrete flatwork, masonry partitions, metal doors and frames, aluminum stopped windows, exposed wood and standing seam metal roof system, painting, mechanical, plumbing and electrical systems. All in accordance with the contract documents, including Plan File Nos. 538-215/263, located in Tower Park at 4900 Hickman Road and Sheridan Park at 4000 East Hull Avenue, Des Moines, Iowa.

- Sealed bids for said improvement were submitted by the following bidders:
 - o Burkett Construction, LLC, Winterset, IA
 - Edge Commercial, LLC, Grimes, IA Bid not read Power of Attorney is not sealed.
- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on May 8, 2018.
- There were two (2) bids submitted and only one (1) of the two (2) bids could be read, which was submitted by Burkett Construction, LLC, (Andrew Burkett, Owner, 2341 Carver Road, Winterset, Iowa, 50273) in the amount of \$450,410, which was 31% over the project estimate of \$343,800. Engineering staff contacted the four (4) other plan holders that indicated they would be prime bidders to find out why they did not submit a bid, and two (2) indicated they were busy and would be more interested in bidding later in the summer and the other two (2) said the project was not something they were interested in. Park and Recreation staff has reevaluated the project and project completion and have asked Engineering staff to meet with the design architects to make changes to the project, to bid later in the summer and to extend the completion date. The construction of these restroom facilities will still be coordinated with the construction of new water playgrounds in these respective parks.
