AGENDA HEADING:

Hearing on Hubbell Avenue and University Avenue Intersection Improvements: Resolution approving plans, specifications, form of contract documents, engineer’s estimate, receive and file bids, and designating lowest responsible bidder as Hawkeye Paving Corporation, Anthony L. Perkins, President, \$170,665.

SYNOPSIS:

This is a public hearing to allow for public input on the Hubbell Avenue and University Avenue Intersection Improvements and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The project includes intersection and traffic signal modifications at the southwest corner of Hubbell Avenue and University Avenue.

FISCAL IMPACT:

Amount: \$170,665 Construction Contract (\$187,000 City Engineer's Estimate)

Funding Source: 2018-2019 CIP, Page Streets – 45, Traffic Signals, Channelization, and School Crossings, TR091, G. O. Bonds

ADDITIONAL INFORMATION:

- On May 7, 2018, under Roll Call No. 18-0748, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Hubbell Avenue and University Avenue Intersection Improvements. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Hubbell Avenue and University Avenue Intersection Improvements, 04-2017-015. The improvement includes 10-inch Portland Cement Concrete (PCC) pavement, 10-inch thick curb & gutter, 6-inch PCC median island, 5-inch and 6-inch PCC sidewalk, decorative brick color and patterned PCC, traffic signal modifications, earthwork, modified subbase, scarification, Hot Mix Asphalt (HMA) surface, traffic control, other incidental items; all in accordance with the contract documents including Plan File Nos. 585-057/072, located at the southwest corner of Hubbell Avenue and University Avenue, Des Moines, Iowa.

- Sealed bids for said improvement were submitted by the following bidders:
 - Hawkeye Paving Corporation, Bettendorf, IA
 - TK Concrete, Inc., Pella, IA
 - MPS Engineers, P.C. d/b/a Kingston Services, P.C., Des Moines, IA

- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on May 22, 2018.

- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Hawkeye Paving Corporation, Anthony L. Perkins, President, 801 42nd Street South, Bettendorf, IA, 52722 for \$170,665, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
