**AGENDA HEADING:**

Amending Water Quality Initiative Urban Conservation Demonstration Projects cost-share grant contract with Iowa Department of Agriculture and Land Stewardship (IDALS) for construction of a stormwater wetland in the Fourmile Creek watershed.

**SYNOPSIS:**

Recommend approval of Cost-Share Grant Contract Amendment #1 with IDALS to install a stormwater wetland in the Fourmile Creek watershed. Project completion date is amended to June 30, 2019 while all other provisions of original agreement remain unchanged.

**FISCAL IMPACT: NONE**

**ADDITIONAL INFORMATION:**

- The proposed stormwater wetland project is being coordinated jointly with the Polk County Soil and Water Conservation District and the Fourmile Creek Watershed Management Authority.
- The initial grant agreement anticipated construction in spring 2018; however, final site selection and preliminary design took longer than initially assumed. City staff discussed with IDALS grant staff and now recommended extending the estimated project completion date to June 30, 2019.
- Design and permitting for the project are being finalized for the stormwater wetland on existing City-owned property near 2403 E. 34<sup>th</sup> Street with an anticipated construction contract award by October 2018.
