AGENDA HEADING:

Approve reinstatement of ACCENT Neighborhood to the Neighborhood Revitalization Program as a recognized neighborhood with proposed expanded boundaries.

SYNOPSIS:

On June 26, 2017, the City Council approved to suspend the ACCENT Neighborhood from the list of recognized neighborhoods for six (6) months to allow the neighborhood time to organize. An extension was granted until August 5, 2018.

The neighborhood has now reorganized and requested to be reinstated as a recognized neighborhood with expanded boundaries.

ADDITIONAL INFORMATION:

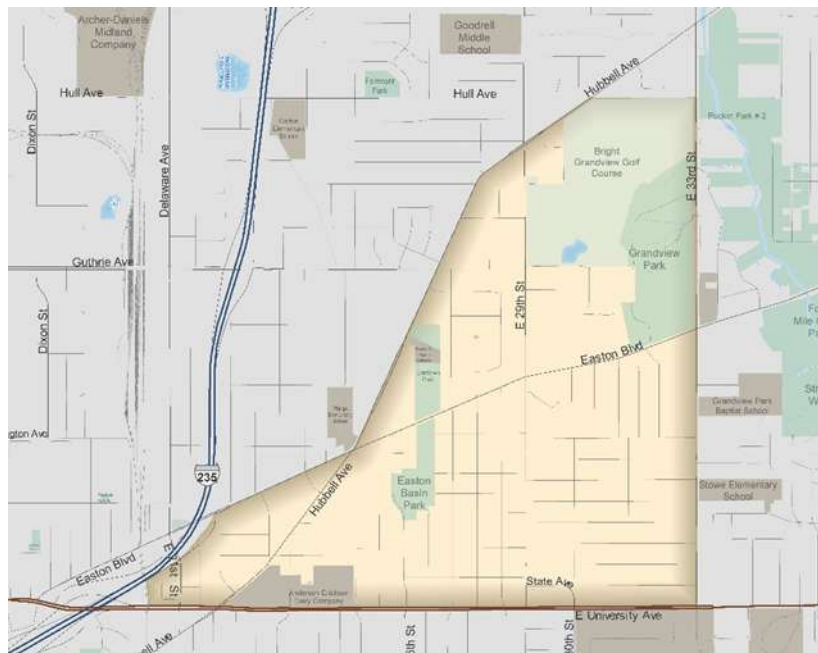
- As part of the City’s Neighborhood Recognition Policy, recognized neighborhoods are required to submit a completed neighborhood survey annually to maintain their recognized status.
- In response to the 2017 neighborhood survey, ACCENT Neighborhood had indicated that while the membership of the neighborhood had doubled at the time, they were unable to get members to serve on the ACCENT Neighborhood Association Board.
- As a result, the ACCENT Neighborhood was unable to meet the requirements of the City’s Neighborhood Recognition Policy and had requested City Staff to remove ACCENT Neighborhood Association from the list of recognized neighborhood associations.
- On June 26, 2017, the City Council approved to suspend ACCENT Neighborhood from the list of recognized neighborhoods for six (6) months to allow the neighborhood time to reorganize.
- On February 5, 2018, the City Council approved to extend this suspension until August 5, 2018, to provide additional time to reorganize.
- While in suspension, the neighborhood reorganized its membership, and has elected officers to serve on the Board.

- The neighborhood has submitted a request to be reinstated into the Neighborhood Revitalization Program with expanded neighborhood boundaries.
