AGENDA HEADING:

Approving purchase of Select Subscriber Program and Agreement with Bentley Systems Incorporated (Bentley) for software license and software support services.

SYNOPSIS:

Recommend approval of the purchase of Select Subscriber Program and Agreement with Bentley, for software license and software support services, in the amount of \$64,668.40 with Bentley (Antonio Ierardo, Vice President, 685 Stockton Drive, Exton, Pennsylvania, 19341), for software licensing and the software support services for a one (1) year duration and authorization for the City Engineer to procure Bentley annual software maintenance, upgrade and support for future fiscal years as long as it is budgeted for and used as the City’s tool for Computer Aided Design & Drafting (CADD) and Civil Engineering design.

FISCAL IMPACT:

Amount: \$64,688.40

Funding Source: Operating Budget, Object 525195, with Operating Budgets of: Engineering, Information Technology, Public Works, Parks & Recreation, and Wastewater Reclamation Authority

ADDITIONAL INFORMATION:

- Various departments throughout the City utilize the MicroStation Software, where Bentley is the sole area-wide provider of this software and support services. The MicroStation Software includes CADD as well as functions for infrastructure design, engineering, and modeling. The Information Technology (IT) Department and the Engineering Department desires to renew the MicroStation Software License with Bentley Systems. There are 30 computers that have MicroStation Software installations. Bentley is the sole area-wide provider of this software and support services, and has licensed and provided support per the existing licensing agreement that will be expiring June 18, 2018.
- The IT Department and Engineering Department staff recommends approval of the Select Subscriber Program and Agreement to provide for licensing and support services for a one (1) year period of June 19, 2018 thru June 18, 2019, at a cost of \$64,688.40.

- Municipal Code section 2-726 (d) provides for a non-competitive procurement of goods and/or service that are of such a nature that they are the only good and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing city need, materials or equipment to be cost effective.
- Funding has been programmed in the Operating Budgets of the respective departments that have MicroStation Software installations. The City Engineer is authorized to procure and execute future fiscal year agreements that have been budgeted.
