AGENDA HEADING:

Approval of change order for repair to an aerial apparatus (ladder truck) for the Fire Department by Sutphen Corporation.

SYNOPSIS:

Approval of the estimated change order for the additional repair of an aerial apparatus (ladder truck) for the Fire Department by Sutphen Corporation (1653 W County Line Road, Springfield, Ohio 45502). During the current repair from the hit and run accident, it was identified that the storing cradle framework for the aerial device had been compromised and needs to be replaced and repaired.

FISCAL IMPACT:

Amount: \$39,630.97

Funding Source: Fiscal Year (FY) 2019 Operating Budget FD100000 page 105, Maintenance and Repair

ADDITIONAL INFORMATION:

- During the council authorized repair of the aerial apparatus, from a hit and run accident, it was discovered that additional repairs are needed.
- Under the Procurement Administrator’s authority, an initial change order was approved for repairs related to cracked windshields, hydraulic valves, and additional sheet metal work. This was in the amount of \$9,991.67.
- Prior to recertification testing at Sutphen, it was noted that the storage cradle framework was damaged and in need of repair. Upon further inspection it was discovered the storage cradle framework needed to be replaced to complete the repairs. This created the need for a second change order for the additional repairs and requires Council consideration and approval in the amount of \$39,630.97.
- The total repairs to this apparatus are still less than 10% of the cost of a new apparatus, similarly capable and equipped, and supports the City’s GuideDSM goals being a high performing City organization as well as being a financially sound City organization.
