AGENDA HEADING:

Approval of amendment to Professional Services Agreement (PSA) with RDG Planning and Design (RDG) for the development of the Douglas Avenue Corridor Plan.

SYNOPSIS:

Recommend approval for extending the contract term to January 31, 2019 and the expenditure of an additional \$40,400 in fees to conduct a traffic study to evaluate improvement strategies along Douglas Avenue.

ADDITIONAL INFORMATION:

- On August 23, 2016, the Douglas Avenue Coalition submitted a formal request to the Community Development Department for assistance in completing a corridor plan for Douglas Avenue.
- On September 11, 2017, the City of Des Moines approved hiring RDG to prepare a Corridor Plan for Douglas Avenue for the purpose of revitalizing this commercial corridor between Merle Hay Road and the Des Moines River.
- The consultant team has conducted multiple visioning meetings and surveys that have engaged more than 200 residents, business owners, and stakeholders in the planning process. Community consensus indicates a strong desire to reconfigure a portion of the corridor from a 4-lane undivided cross section to a 3-lane cross section with center turn lane.
- Douglas Avenue also serves as U.S. Highway 6 and is under the jurisdiction of the Iowa Department of Transportation (IDOT). The IDOT has inquired about additional information regarding crash history analysis and traffic volume forecasts.

• The additional traffic study will further evaluate safety and traffic volume data to evaluate preliminary improvement strategies that consider change in cross section and intersection improvements. This effort is being coordinated with MoveDSM initiatives.
