


- On August 28, 2017, by Roll Call No. 17-1461, the City Council approved designation of Watrous Heights Neighborhood as a recognized neighborhood for the City of Des Moines.
- Watrous Heights Neighborhood has submitted a request to expand its neighborhood boundaries.
- The boundaries for the existing neighborhood include S. W. 9th Street between Watrous Avenue and McKinley Avenue on the west, S. Union Street from Watrous Avenue to McKinley Avenue on the east, Watrous Avenue between S.W. 9th Street and S. Union Street on the north, and McKinley Avenue between S.W. 9th Street to S. Union Street on the south.
- The boundaries for the proposed expansion include S. W. 9th Street between Park Avenue and McKinley Avenue on the west, S. Union Street from Park Avenue to McKinley Avenue on the east, Park Avenue between S.W. 9th Street and S. Union Street on the north, and McKinley Avenue between S.W. 9th Street to S. Union Street on the south.
- The proposed boundaries match up with the Watrous South and Grays Lake neighborhood to the west, Indianola Hills to the north, Fort Des Moines neighborhood to the south and Magnolia Park neighborhood to the east.
