ADDITIONAL INFORMATION:

- On August 6, 2018, by Roll Call No. 18-1315, City Council approved Change Order No. 3 with Des Moines Asphalt & Paving for additional work on the 2018 HMA Residential Paving Program, not to exceed \$235,000. This additional work under Change Order No. 3 added the reconstruction of areas of Cummins Parkway between University Avenue and Merle Hay Road that were damaged from the June 30, 2018 flood event.
- Public Works and Engineering staff identified additional portions of Cummins Parkway (not damaged by the flood event) that need rehabilitation and determined it would be most efficient, cost effective, and beneficial to the public to rehabilitate those adjacent areas at the same time the flood damaged areas are reconstructed. Change Order No. 4 adds deteriorated portions of Cummins Parkway (areas not damaged by the flood event) adjacent to the flood damaged areas to the contract.
