AGENDA HEADING:

Authorizing transfer of surplus funds from the Des Moines Stormwater Management Utility to the City of Des Moines to fund the 2018 Limited Voluntary Flood Damaged Property Buyout project.

SYNOPSIS:

Recommended approval of resolution to transfer unencumbered funds from Des Moines Stormwater Management Utility into a separate sub-fund of the City General Fund to fund a portion of the 2018 Limited Voluntary Flood Damaged Property Buyout project. These stormwater funds will be used to cover a portion of the cost relating to the damaged properties from the June 30, 2018 and July 1, 2018 storm events. The City Finance Department analyzed the financial stability of the Des Moines Stormwater Management Utility and determined the funds were available after making all deposits into all funds required by the terms, covenants, conditions and provisions of outstanding revenue bonds, pledge orders and other obligations which are payable from the revenues of the Des Moines Stormwater Management Utility.

FISCAL IMPACT:

<u>Amount</u>: \$9,500,000

<u>Funding Source</u>: Available surplus funds from the Des Moines Stormwater Management Utility transfer to a sub-fund of the City General Fund.

ADDITIONAL INFORMATION:

- The surplus transfer is intended to fund a portion of the 2018 Limited Voluntary Flood Damaged Property Buyout Project for the voluntary acquisition and demolition of flood damaged residential properties for total costs not to exceed \$11,500,000.
- Upon completion of all acquisition and demolition activities under the 2018 Limited Voluntary Flood Damaged Property Buyout Project, the City Manager and Finance Director will transfer all remaining unused surplus funds from the sub-fund of the General Fund to the Des Moines Stormwater Management Utility.
