# AGENDA HEADING:

Recommend approval of a contract with the City of Des Moines and Motorola Solutions Inc. (500 W. Monroe Street., Suite 4400, Chicago, IL 60661, Greg Brown, CEO) for providing a replacement public safety radio communications system for the City of Des Moines and authorizing the City Manager to carryout terms, conditions, and requirements of the agreement.

### **SYNOPSIS:**

City Council authorized Motorola as the preferred vendor to provide a replacement radio system on August 6, 2018. City staff was directed to negotiate the scope and overall price of the system and bring back to Council for approval. Through the negotiation process, the City has reduced the overall cost of the contract to \$9,600,000. Given the complex nature of the system and potential project changes, \$1,900,000 in contingency costs are budgeted for a total not to exceed cost of \$11,500,000.

## FISCAL IMPACT:

<u>Amount</u>: \$11,500,000 Budget

- \$9,600,000 base payments to Motorola according to a milestone schedule.
- \$400,000 in short-term contingency costs.
- \$1,500,000 in long-term contingency should more substantive changes be needed to the system. Bonds will only be issued for this amount if needed.

<u>Funding Source</u>: 2018-2019 CIP, Page Miscellaneous - 13, Public Safety Communication System Upgrade, MS018, Being: \$10,000,000 G.O. Bonds to be issued – July 2019; additional \$1,500,000 G.O. Bonds if necessary.

## **ADDITIONAL INFORMATION:**

- To reduce costs, the City has made the following changes to Motorola's proposal:
  - Selected a 2-site local enhancement rather than the more expensive 4-site proposal. The 2-site proposal will still ensure that radio communication is possible on-street and inbuilding throughout the City by utilizing five (5) Iowa Statewide Interoperable Communications System (ISICS) sites.

- Eliminated 50% of test equipment included in the proposal.
- City staff at the Radio Shop or Fire Maintenance and Repair will remove and replace 30% of mobile radios from vehicles and program 70% of the portable radios.
- Reduced chances of failure by creating greater redundancy by eliminating the single path to the Dispatch Center.
- To maximize Motorola's end of quarter discounts, the contract will need to be executed by September 30, 2018.
