**AGENDA HEADING:**

Approving an intergovernmental 28E Agreement with Metropolitan Advisory Council (MAC) member communities of Altoona, Bondurant, Carlisle, Grimes, Johnston, Norwalk, Pleasant Hill, Polk County, Polk City, Windsor Heights, and West Des Moines for funding and maintenance of Homeland Security Services.

**SYNOPSIS:**

Approval of a 28E Agreement with members of the Metropolitan Advisory Committee for cost sharing of the Homeland Security Initiative proposed by the City of Des Moines commencing July 1, 2018, and continue through June 30, 2023. The communities of Johnston and West Des Moines have joined while no communities have withdrawn since the FY 2016 agreement renewal.

**FISCAL IMPACT:**

Amount:

- Revenue from member communities: \$179,775 in each fiscal year (FY) beginning in FY 2019 through FY 2023. This is an increase of \$105,180 over the prior agreement due to the additions of Johnston and West Des Moines.
- Total cost of the Des Moines Metro STAR and Bomb Squad for FY 2019 is \$1,491,318 in FY 2019.

Funding Source: FY 2019 Recommended Operating Budget Metro Special Weapons Response Section (PD221366) page 190 and Bomb Squad (PD221367) page 191.

**ADDITIONAL INFORMATION:**

- This is a continuation of an agreement which began in 2007 to provide certain tactical and bomb squad services to suburban communities. Initially the agreement included all metro-area suburbs, but prior to the FY 2016 agreement the communities of West Des Moines, Clive, Urbandale, Johnston and Waukee withdrew to use services provided by the State. West Des Moines and Johnston have rejoined in the agreement.

- The agreement ensures the accepting communities Homeland Security services that are provided by the City of Des Moines in conjunction with Polk County:
  - Metro Special Weapons Response Section which provides a federal Type II Weapons of Mass Destruction (WMD) and Chemical, Biological, Radiological, Nuclear, and Explosive (CBRNE) Tactical Response Team.
  - Des Moines Bomb Squad providing federal Type I Explosive Ordinance Devise Mitigation Response.
  - Des Moines Police Identification Section assisting in the collection and preservation of evidence located in hazardous environments for contaminated crime scene processing.
