# **AGENDA HEADING:**

Recommend approval of the purchase of one (1) replacement compact four-wheel drive rubber tired end loader with equipment accessories per the State of Iowa Department of Administrative Services (IDAS) contract 17265A from Murphy Tractor and Equipment Company, (Thomas Udland, President, 5087 NE 46<sup>th</sup> Avenue, Des Moines, IA 50317) at a total cost \$92,563.36.

# **ADDITIONAL INFORMATION:**

• A 2006 model year compact rubber tired loader with bucket and a snow plow that exceeds replacement criteria was approved for replacement by the Fleet Oversight Committee. A replacement unit meeting the needs of the Property Cleanup Division is available from two (2) established cooperative government purchasing contracts Sourcewell and the IDAS equipment purchasing contract. Quotes were solicited and compared from each contract. The results are shown in the table below. The lower cost from IDAS contract is also \$11,576 less than a similar unit acquired in 2014 under competitive bid specifications. Therefore, the recommended award is to Murphy Tractor and Equipment Company, utilizing the IDAS contract.
