This project provides for the replacement deteriorated decking material with composite decking on the right field deck at Principal Park.

Amount: \$167,400 Construction Contract (\$185,000 City Engineer's Estimate)



ADDITIONAL INFORMATION:

- On October 22, 2018, under Roll Call No. 18-1723, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Principal Park Outfield Deck Improvements. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Principal Park Outfield Deck Improvements, 04-2019-003. The improvement includes the removal and disposal of the existing decking material on the right field deck and replacement with composite decking material; all work in accordance with the contract documents including Plan File Nos. 598-176/183, located at the Principal Park, One Line Drive, Des Moines, Iowa.
