AGENDA HEADING:

Approving Professional Services Agreement (PSA) with Snyder & Associates, Inc. for professional services for 6th Avenue Streetscape Phase 2, not to exceed \$464,054.

SYNOPSIS:

Approving the PSA with Snyder & Associates, Inc., David N. Moeller, President, 2727 SW Snyder Boulevard, Ankeny, Iowa, 50023 for a total cost not to exceed \$464,054 based on hourly rates to provide design and construction phase services for 6th Avenue Streetscape Phase 2.



ADDITIONAL INFORMATION:

- The 6th Avenue Streetscape Phase 1 construction contract has been awarded to Hawkeye Paving, and is anticipated to be completed in spring 2020. The Phase 2 construction is expected to start in spring of 2020.
- The 6th Avenue Streetscape project includes reducing the number of travel lanes from 5-lanes to 3-lanes and construction of wider sidewalks, bus shelters, street trees, green infrastructure, landscaping, benches, bike racks, and other pedestrian amenities.
- The 6th Avenue Streetscape is planned to be constructed over three (3) phases from Hickman Road to I-235:
 - o Phase 1 will include Hickman Road to College Avenue.
 - o Phase 2 will include College Avenue to University Avenue.
 - o Phase 3 will include University Avenue to I-235

- A Request for Proposals (RFP) for professional services for the 6th Avenue Streetscape Phase 2 was issued, posted on the City's website, and printed in the newspaper. A selection committee of Engineering and Community Development staff reviewed and rated the 10 proposals received in response to the RFP. Snyder & Associates, Inc. was selected based upon the selection criteria in the RFP and Snyder & Associates, Inc. thorough project approach and understanding and related project experience.
- Staff has negotiated a PSA with Snyder & Associates, Inc. for a total cost not to exceed \$464,054 based on hourly rates for design and construction phase services for 6th Avenue Streetscape Phase 2
