#### **AGENDA HEADING:**

Acceptance of proposal from MidAmerican Energy Company for relocation of gas facilities for the Leetown Creekway Box Culvert project in the amount of \$259,134.35.

## **SYNOPSIS:**

Recommend approval of the proposal from MidAmerican Energy Company for relocation of gas facilities for the Leetown Creekway Box Culvert project, to accommodate construction of the proposed box culvert through the Iowa State Fairgrounds.

#### ADDITIONAL INFORMATION:

- This Leetown Creekway Box Culvert project from Dean Avenue to University Avenue, and traversing through the Iowa State Fairgrounds, was awarded to S.M. Hentges & Sons, Inc. on September 11, 2017 by Roll Call No. 17-1613.
- The Leetown Creekway Box Culvert project includes constructing a new 12-foot by 5-foot box culvert from Dean Avenue to University Avenue, which will reduce the amount of storm water that currently flows to an existing 5-foot by 6-foot concrete box culvert and an existing 48-inches diameter culvert that traverse underneath existing buildings located at the Iowa State Fairgrounds.
- The Leetown Creekway Box Culvert project was in conflict with existing MidAmerican Energy Company gas facilities on the Iowa State Fairgrounds. The proposal from MidAmerican Energy Company is for work necessary to relocate the gas facilities in conflict with the Leetown Creekway Box Culvert project.
- A preliminary estimate of \$650,000 was originally provided by MidAmerican Energy Company to relocate the gas main. Relocation work was completed by MidAmerican Energy Company for an actual cost of \$259,134.35.
