### AGENDA HEADING:

Approving and authorizing the execution of the revisions to the Programmatic Agreement among the Iowa Department of Natural Resources (IDNR), Iowa State Historical Preservation Office (ISHPO), Iowa Office of the State Archaeologist and the City of Des Moines regarding the Des Moines Sewer Separation Project, Des Moines, Polk County, Iowa.

### SYNOPSIS:

Recommend approval and execution of the revisions to the Programmatic Agreement among the IDNR, ISHPO, Iowa Office of the State Archaeologist and the City of Des Moines regarding the Des Moines Sewer Separation Project, Des Moines, Polk County, Iowa. This Programmatic Agreement is required for assessment of the potential impact on natural and cultural resources is required for the Lower Oak Park and Highland Park Sewer Separation project, Near West Side Sewer Separation project, River Bend and King Irving Sewer Separation project and future sewer separation projects financed by the Clean Water State Revolving Fund (SRF).

This revision to the Programmatic Agreement includes modifying sections of Appendix A, B, and E as follows:

- Revising phasing and topographic maps depicting project areas for the Near West Side Sewer Separation Project and the River Bend and King Irving Sewer Separation Project.
- Revising aerial maps for new storm sewer piping and alignment changes to proposed storm sewer piping for the Near West Side Sewer Separation Project and the River Bend and King Irving Sewer Separation Project.
- Revising aerial map for new storm water basin and moving construction of storm sewer into the boundary of the Woodland Cemetery for the Near West Side Sewer Separation Project.

### ADDITIONAL INFORMATION:

- On April 17, 2017, by Roll Call No. 17-0655, City Council approved and authorized the execution of the Programmatic Agreement with the IDNR, ISHPO, and the Iowa Office of the State

Archaeologist regarding the Des Moines Sewer Separation Project, which included the Lower Oak Park & Highland Park Sewer Separation Project and Near West Side Sewer Separation Project.

- On December 4, 2017, by Roll Call No. 17-2043, City Council approved and authorized the execution of the Revision to the Programmatic Agreement to reflect changes in project locations and phasing for the Lower Oak Park and Highland Park Sewer Separation Project and Near West Side Sewer Separation Project.
- On February 19, 2018, by Roll Call No. 18-252, City Council approved and authorized the execution of the amendment to the Programmatic Agreement with the IDNR, ISHPO, and the Iowa Office of the State Archaeologist regarding the Des Moines Sewer Separation Project which added the River Bend and King Irving Sewer Separation project.
- On July 9, 2018, by Roll Call No. 18-1143, City Council approved and authorized the execution of this revision to the Programmatic Agreement includes modifying Appendix B to reflect changes to storm sewer alignments on the River Bend and King Irving Sewer Separation project.
- This revision to the Programmatic Agreement includes modifying sections of Appendix A, B, and E as follows:
  - Revising phasing and topographic maps depicting project areas for the Near West Side Sewer Separation Project and the River Bend and King Irving Sewer Separation Project.
  - Revising aerial maps for new storm sewer piping and alignment changes to proposed storm sewer piping for the Near West Side Sewer Separation Project and the River Bend and King Irving Sewer Separation Project.
