### AGENDA HEADING:

Hearing on 2019 Sidewalk Replacement Program: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Kingston Services, LLC, Amit A. Pradhan, Vice President, \$417,920.

### SYNOPSIS:

This is a public hearing to allow for public input on the 2019 Sidewalk Replacement Program and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for a Citywide program to replace deteriorated City sidewalks, sidewalks damaged by City activities or by City trees in the parkway, and sidewalks for residents that qualify for the special assessment subsidy.

### FISCAL IMPACT:

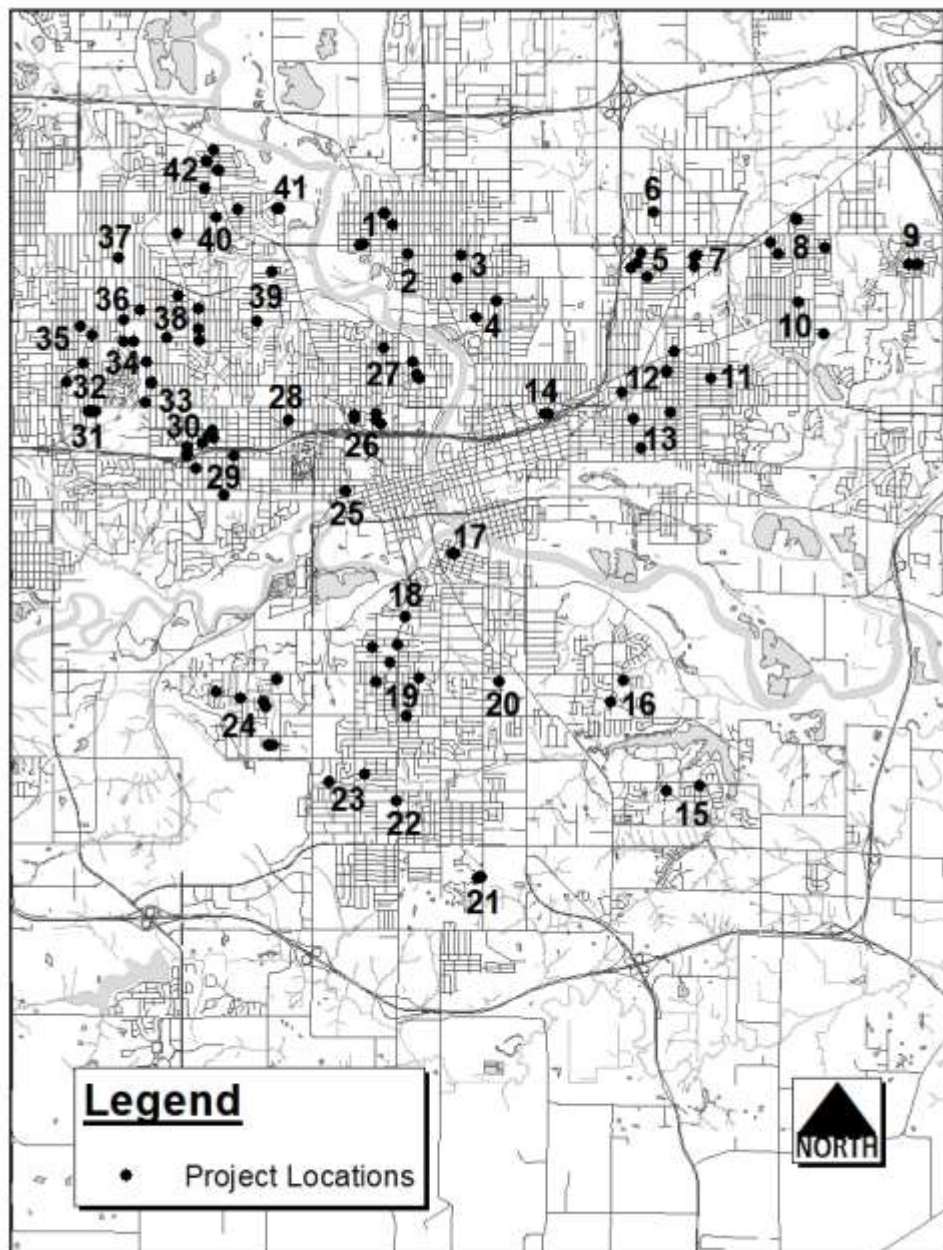
Amount: \$417,920 Construction Contract (\$425,000 City engineer's estimate)

Funding Source: 2019-2020 CIP, Page Street – 29, Sidewalk Replacement, SW084, G.O. Bonds to be issued.

### ADDITIONAL INFORMATION:

- On March 25, 2019, under Roll Call No. 19-0449, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2019 Sidewalk Replacement Program. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2019 Sidewalk Replacement Program, 09-2019-001. The improvement includes reconstruction of brick sidewalks, Class A and Class B Portland Cement Concrete (PCC) sidewalks of varying thicknesses, together with all appurtenances; in accordance with the contract documents, at various Citywide locations. Sidewalks will be replaced at locations inspected by the Engineering Department. Curb ramps, compliant with the requirements of the Americans with Disabilities Act (ADA) of 1990 and the regulations associated with this law, as it applies to pedestrian facilities, will also be constructed in the vicinity where sidewalks will be replaced.

- Sealed bids for said improvement were submitted by the following bidders:
  - Kingston Services, LLC, Des Moines, IA
  
- The bids were received and opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on April 9, 2019.
  
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Kingston Services, LLC, Amit A. Pradhan, Vice President, 1444 Illinois Street, Des Moines, IA, 50314 in the amount of \$417,920, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
