AGENDA HEADING:

Initiate amendment to the Sherman Hill Local Historic District to align its boundary with the boundary of the Sherman Hill Historic District as listed on the National Register of Historic Places.

SYNOPSIS:

- The Sherman Hill Association requests that the boundary of the Sherman Hill Local Historic District be amended to match the boundary of the district as listed on the National Register of Historic Places.
- A map identifying the proposed changes is included in the City Council packet.
- The requested action would include sending a notice to impacted property owners; hearings before the Historic Preservation Commission, and the Plan and Zoning Commission; review by the Iowa Department of Cultural Affairs; and a hearing before the City Council.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

- The Sherman Hill Association requests that the boundary of the Sherman Hill Local Historic District be amended to match the boundary of the district as listed on the National Register of Historic Places.
- The existing boundary was set in 1983 when the local historic district was established. This was prior to the reconstruction of Martin Luther King, Jr. Parkway. Traffic and development patterns have changed as a result.
- In 2012, an amended National Register of Historic Places Registration Form was approved, which updated the boundary set in 1979 when the district was first listed on the National Register.
- The requested action would include sending a notice to impacted property owners; hearings before the Historic Preservation Commission, and the Plan and Zoning Commission; review by the Iowa Department of Cultural Affairs; and a hearing before the City Council. This process is established by Section 58-29 of the Municipal Code.
