## **ADDITIONAL INFORMATION:**

• During the process of completing the urban renewal tax increment financing (TIF) certifications and annual urban renewal report the agreement was discovered to provide that City shall pay to 7&Grand, a grant payable in six (6) semi-annual installments payable each December 1<sup>st</sup> and May 1<sup>st</sup> in an amount of the applicable percentage of the project TIF starting December 1, 2019. This roll call allows for the advancement of payment for the December 1, 2019 and May 1, 2020 from a sub-fund of the City general fund and to be reimbursed with TIF revenue within the TIF certifications that are due December 1, 2019.
