AGENDA HEADING:

Approving Supplemental Agreement No. 1 to the Professional Services Agreement (PSA) with Snyder & Associates, Inc. for additional design and construction phase services for 47th Street and Holcomb Reconstruction, not to exceed \$42,500.

SYNOPSIS:

Recommend approval of the Supplemental Agreement No. 1 to the PSA with Snyder & Associates, Inc., (David N. Moeller, President, 2727 SW Snyder Boulevard, Ankeny, Iowa, 50023) for an additional amount not to exceed \$42,500, based on hourly rates, to provide additional design and construction phase services for 47th Street and Holcomb Reconstruction.

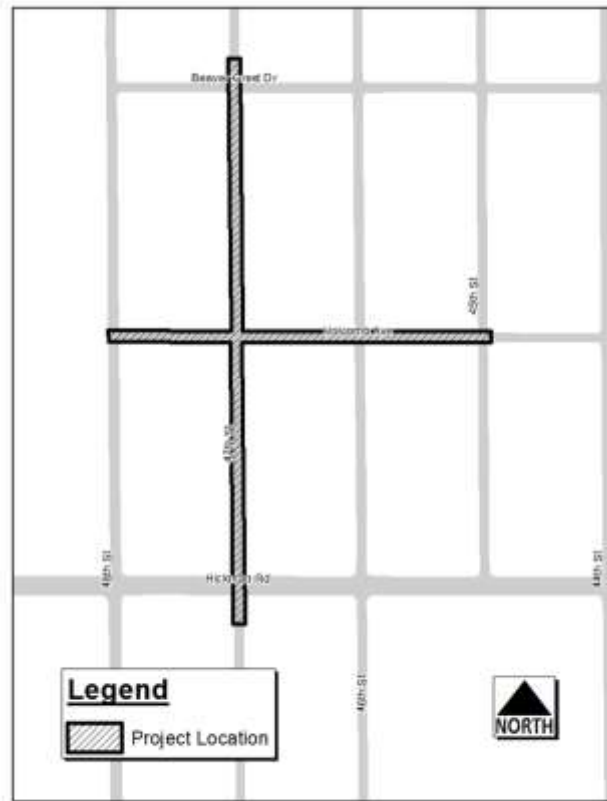

ADDITIONAL INFORMATION:

- On December 17, 2018, by Roll Call No. 18-2046, City Council approved the PSA with Snyder & Associates, Inc. to provide design phase services for 47th Street and Holcomb Avenue Reconstruction.
- The 47th Street and Holcomb Avenue Reconstruction project includes:
 - Reconstruction of 47th Street from Hickman Road to Beaver Crest Drive and Holcomb Avenue from 46th Street to 48th Street.
 - Construction of stormwater management improvements along 47th Street from Hickman Road to Beaver Crest Drive.
- Staff has negotiated Supplemental Agreement No. 1 to the Agreement for Professional Services with Snyder & Associates, Inc. for a total additional amount not to exceed \$42,500, based on hourly rates, to complete design for an additional sanitary sewer main and provide construction administration services for 47th Street and Holcomb Reconstruction.
- Construction has previously commenced and is currently ongoing.
