## AGENDA HEADING:

Ordering construction of the following: Martin Luther King Jr. Parkway Rehabilitation from Hickman Road to Euclid Avenue - Receiving bids, (2-25-20), and Setting date of hearing, (3-23-20).  
Construction Estimate - \$1,700,000.

## SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for the resurfacing of Martin Luther King Jr. Parkway from Hickman Road to Euclid Avenue.



## ADDITIONAL INFORMATION:

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Martin Luther King Jr. Parkway Rehabilitation from Hickman Road to Euclid Avenue, 06-2020-003. The improvement includes Portland Cement Concrete (PCC) full depth patches, sidewalk, driveways, medians, milling, Hot Mix Asphalt (HMA) overlay, modified subbase, subdrain, storm sewer intakes, pavement markings, traffic control, seeding, miscellaneous associated work including cleanup and restoration; all in accordance with the contract documents, including Plan File Nos. 615-209/243, located at Martin Luther King Jr. Parkway from Hickman Road to Euclid Avenue.
- The estimated construction cost is \$1,700,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
- Construction is anticipated to be complete by December 2020.
