AGENDA HEADING:

Hearing on 2020 Traffic Signal Replacement Contract 2: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Van Maanen Electric, Inc., Nathan S. Van Maanen, President, \$512,624.

SYNOPSIS:

This is a public hearing to allow for public input on the 2020 Traffic Signal Replacement Contract 2 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The project includes replacement of traffic signals at the intersection of Lower Beaver Road and Madison Avenue and the intersection of 19th Street and Clark Street.



ADDITIONAL INFORMATION:

- On January 13, 2020, under Roll Call No. 20-0013, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2020 Traffic Signal Replacement Contract 2. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2020 Traffic Signal Replacement Contract 2, 04-2020-008. The improvement includes new traffic signals, vehicle loop detectors, Hot Mix Asphalt (HMA) pavement, Portland Cement Concrete (PCC) sidewalk, pavement markings, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 613-188/224, located at the intersection of Lower Beaver Road and Madison Avenue and the intersection of 19th Street and Clark Street.
- Sealed bids for said improvement were submitted by the following bidders:
 - Van Maanen Electric, Inc., Newton, IA
 - Minturn, Inc., Brooklyn, IA
 - Jasper Construction Services, Inc., Newton, IA

- The bids were received and opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on January 28, 2020.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Van Maanen Electric, Inc. (Nathan S. Van Maanen, President, 500 Iowa Speedway, Newton, IA, 50208), in the amount of \$512,624, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
