# AGENDA HEADING:

Ordering construction of the following: Fourmile Community Center Renovation and Sprinkler System - Receiving bids, (3-24-20), and Setting date of hearing, (4-20-20). Construction Estimate - \$500,500.

### SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project adds a fire suppression system and interior renovations to the kitchen, rental space and fitness room to better utilize under used space in the community recreation center, to better serve clients' current needs and provide for flexibility as future needs evolve.

### **FISCAL IMPACT:**

Amount: \$500,500 City Engineer's Estimate

<u>Funding Source</u>: 2019-2020 CIP, Page Park – 8, Community Recreation Center Improvements, PK033, Being: \$413,500 G.O. Bonds issued, \$37,000 transfer from BL110, and \$50,000 transfer from BL074.

# **ADDITIONAL INFORMATION:**

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Fourmile Community Center Renovation and Sprinkler System, 11-2019-012. The improvements include the addition of a new fire suppression sprinkler system, updates to the fire alarm system, reconfigure areas to better utilize space, renovation of the kitchen and rental space, and relocation of the fitness equipment room; all in accordance with the contract documents, including Plan File Nos. 602-202/267, located at Fourmile Community and Recreation Center, 3711 Easton Boulevard.
- The improvements will enhance the facility amenities and provide an opportunity to fully utilize the available space in the facility.

- The estimated construction cost is \$500,500. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
- Fourmile Community Recreation Center was built in 1973 and is 14,494 square feet in size.
- Recent updates to the facility include:
  - Skatepark constructed in 2000
  - New roof in 2015
  - Renovated parking lot in 2017
  - New playground in 2017
  - Check in desk added in 2018
  - Windows replaced in 2019
