## AGENDA HEADING:

Resolution approving Urban Renewal Development Agreement with 111 Jefferson Ave LLC for redevelopment of 111 Jefferson Avenue.

### SYNOPSIS:

Recommend approval of the Urban Renewal Development Agreement with 111 Jefferson Ave LLC (T. Michael Price, Managing Member, 1540 Roseman Bridge Road, Winterset, IA 50273) for the construction of a \$880,000, 9,000-square-foot warehouse at 111 Jefferson Avenue in Central Place Industrial Park.

# FISCAL IMPACT:

<u>Amount</u>: \$43,500

Funding Source: Central Place Tax Increment Financing (TIF)

### **ADDITIONAL INFORMATION:**

- Commonwealth Electric is currently located on the west side of 2<sup>nd</sup> Avenue, and the construction of this warehouse allows the existing business to further expand.
- In 2019, 111 Jefferson Ave LLC acquired City-owned property in the Central Place Urban Renewal Area at 111 Jefferson Avenue for \$43,500 for commercial development of a 9,000-square-foot warehouse use by tenant, Commonwealth Electric of the Midwest.
- After purchase of the property, the Developer came to learn that the soil is soft and needs stabilization. The costs of over-excavation of footings and rock placement were verified to cost more than the cost of the property (\$79,000 plus).
- Due to these extraordinary development costs and the wish to spur economic development in the area, staff is recommending a forgivable loan equal to the cost of the land, payable upon issuance of a certificate of completion.
