### AGENDA HEADING:

Ordering construction of the following: E. 29th from Easton Blvd to Euclid Avenue Rehabilitation - Receiving bids, (4-21-20), and Setting date of hearing, (5-18-20). (Construction Estimate - \$750,000.00).

### SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project will rehabilitate deteriorated roadway pavement for E. 29th Resurfacing from Easton Boulevard to Euclid Avenue which includes scarification of the existing roadway, resurfacing with hot mix asphalt, and traffic signal modifications.

### FISCAL IMPACT:

Amount: \$750,000 City Engineer's Estimate

Funding Source: 2018-2019 CIP, Page Street – 32, Roadway Reconstruction, ST260, Being: \$500,000 Surface Transportation Block Grant Program Federal-aid Swap funds (80% of eligible construction costs, or \$500,000 max) and \$250,000 Road Use Tax

### ADDITIONAL INFORMATION:

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the E. 29th from Easton Blvd to Euclid Avenue Rehabilitation, 06-2019-006. The improvement includes pavement scarification and Hot Mix Asphalt (HMA) overlay, Portland Cement Concrete (PCC) Patching, PCC sidewalk, pavement markings, traffic signal modifications, and other incidental items; in accordance with the contract documents, including Plans File Nos. 613-225/247, on E. 29th Street from Easton Blvd to Euclid Avenue, Des Moines, Iowa.

The estimated construction cost is \$750,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
