AGENDA HEADING:

Amending the Municipal Code Section 98 relating to the monthly fee charge for the collection and disposal of solid waste services (Solid Waste rate increases).

SYNOPSIS:

Recommend approval of amending the Municipal Code Sections 98-55, increasing monthly collection fees charged for solid waste services by 5% effective on July 1, 2020; increasing the monthly fee reduction from \$3.46 to \$4.13 for solid waste services for 64-gallon containers for those residential owners who qualify for a fee reduction under the Municipal Code Section 98-55(c) effective on July 1, 2020; increasing the monthly fee reduction from \$3.48 to \$4.20 for solid waste services for 96-gallon containers for those residential owners who qualify for a fee reduction under the Municipal Code Section 98-55(c) effective on July 1, 2020.

Recommend approval of amending the Municipal Code Sections 98-55, increasing monthly collection fees charged for solid waste services by 3% effective on July 1, 2021; increasing the monthly fee reduction from \$4.13 to \$4.56 for solid waste services for 64-gallon containers for those residential owners who qualify for a fee reduction under the Municipal Code Section 98-55(c) effective on July 1, 2021; increasing the monthly fee reduction from \$4.20 to \$4.66 for solid waste services for 96-gallon containers for those residential owners who qualify for a fee reduction under the Municipal Code Section 98-55(c) effective on July 1, 2021. This information was initially presented at the December 16, 2019, Council workshop.

FISCAL IMPACT:

Amount: The monthly solid waste collection fees are proposed to increase by 5% beginning July 1, 2020. The fee reduction for residential owners who qualify under Section 98-55(c) will increase to \$4.13 per month for 64-gallon containers and by \$4.20 per month for 96-gallon containers. The monthly solid waste collection fees are proposed to increase by 3% beginning July 1, 2021. The fee reduction for residential owners who qualify under Section 98-55(c) will increase to \$4.56 per month for 64-gallon containers and by \$4.66 per month for 96-gallon containers. Proposed rates follow:

<u>Funding Source</u>: Revenues will be deposited in the appropriate solid waste fund accounts for use on operations and capital projects per the budget plan.

ADDITIONAL INFORMATION:

- At the December 16, 2019 Council workshop, staff presented the operating plans for Solid Waste.
- Fee increases are needed in the Solid Waste Fund to offset annual increases in operating costs and equipment replacement. After the increase, solid waste rates in the City are still below the average for the largest 10 municipalities in the state and below the average of national peers.
