## AGENDA HEADING:

Approving Change Order No. 1 with Merit Construction Services, Inc. for additional work on 2020 Parking Garage Repair Program, in the amount of \$135,460.

## **SYNOPSIS:**

Recommend approval of Change Order No. 1 in an amount not to exceed \$135,460 with Merit Construction Services, Inc. (Doug Bruns, President, 5441 212th Street W., Farmington, Minnesota, 55024), for additional work on 2020 Parking Garage Repair Program.

## FISCAL IMPACT:

# **ADDITIONAL INFORMATION:**

- On May 4, 2020, under Roll Call No. 20-0794, the City Council approved plans and specifications and designated the lowest responsible bidder as Merit Construction Services, Inc. for \$545,850. The project includes the repair of parking garage structural members including concrete removal, reinforcing steel, concrete patching, structural concrete, expansion joint repair, traffic coating, roof cap, and concrete sealing.
- Change Order No. 1 adds a repair to the roof of the daycare located at the 7<sup>th</sup> & Center Park and Ride parking garage and adjusts bid item totals based on measured repair quantities, including additional structural repairs to the garages. The additional quantity of repairs was not discovered until the concrete was exposed and the true existing conditions were identified. These repairs included partial depth concrete repairs, joint repairs overtop of beams, and the ceiling precast repairs. The change order also included additional work to repair the column on the walkway bridge at the 7<sup>th</sup> & Center Park and Ride parking garage. This change order adds 15 working days to the contract.
