#### **AGENDA HEADING:**

Ordering construction of the following: Ingersoll Avenue 42nd Street to Polk Boulevard Reconstruction - Receiving bids, (1-20-21), and Setting date of hearing, (2-22-21). Construction Estimate - \$3,620,000.

## **SYNOPSIS:**

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for the reconstruction of Ingersoll Avenue from Polk Boulevard to 42nd Street. The Ingersoll Avenue corridor will be enhanced to improve safety by complying with the City's Complete Streets Policy and meeting current traffic and parking needs. The existing two-way left turn lane and the majority of parking on the south side of Ingersoll Avenue will be repurposed. The new street configuration will include travel lanes in each direction, on-street parking primarily on the north side of the street, and buffered bike lanes in each direction. These improvements will provide a consistent corridor to connect the improvements along Ingersoll east to Martin Luther King Jr. Parkway. New sidewalks will be constructed to fill-in missing gaps along the corridor.

#### FISCAL IMPACT:

Amount: \$3,620,000 City Engineer's Estimate


<u>Funding Source</u>: \$1,000,000 in Surface Transportation Block Program Federal-aid Swap Project funds being 80% eligible roadway construction costs under STBG-SWAP-1945(853)—SG-77 DOT SWAP, \$210,650 Storm Water Utility Funds, \$164,918.60 Des Moines Water Works, \$250,000 in G.O. Bonds issued transferred from SW081, \$400,000 in G.O. Bonds issued transferred from ST102, \$500,000 in G.O. Bonds issued transferred from ST003, \$625,000 in Gaming Monies, and the remaining \$469,431.40 in G.O. Bonds.

### ADDITIONAL INFORMATION:

• The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Ingersoll Avenue 42nd Street to Polk Boulevard Reconstruction, 06-2019-014. The improvement includes construction of Portland Cement Concrete (PCC) sidewalks, driveways, and Hot Mix Asphalt (HMA) paving, clearing and grubbing, earthwork, modified subbase, subdrains, erosion control, storm sewers, intakes, manholes, traffic control, traffic signals, permeable pavers, pavement markings, and surface

restoration; all in accordance with the contract documents, including Plan File Nos. 620-174/272, on Ingersoll Avenue from Polk Boulevard to 42nd Street.

- The estimated construction cost is \$3,620,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
- Construction of the public improvement is anticipated to begin in early spring 2021, with the majority of work completed in the 2021 construction season and be fully complete in the spring 2022.
