AGENDA HEADING:

Amending Chapter 114 of the Municipal Code regarding Traffic Regulation Changes as follows:

- A. Code changes related to the E Grand Avenue Resurfacing Project – E Grand Avenue from Des Moines River to Pennsylvania Avenue; Pennsylvania Avenue from E Grand Avenue to Des Moines Street; and E 6th Street from E Grand Avenue to Des Moines Street.
- B. Parking Restriction Revisions – SW 6th Street south of Cherry Street.

SYNOPSIS:

Recommend approval of the staff recommendation and the ordinance regarding the traffic regulation changes.

FISCAL IMPACT:

Amount: Costs for sign installations and periodic maintenance of signs and markings.

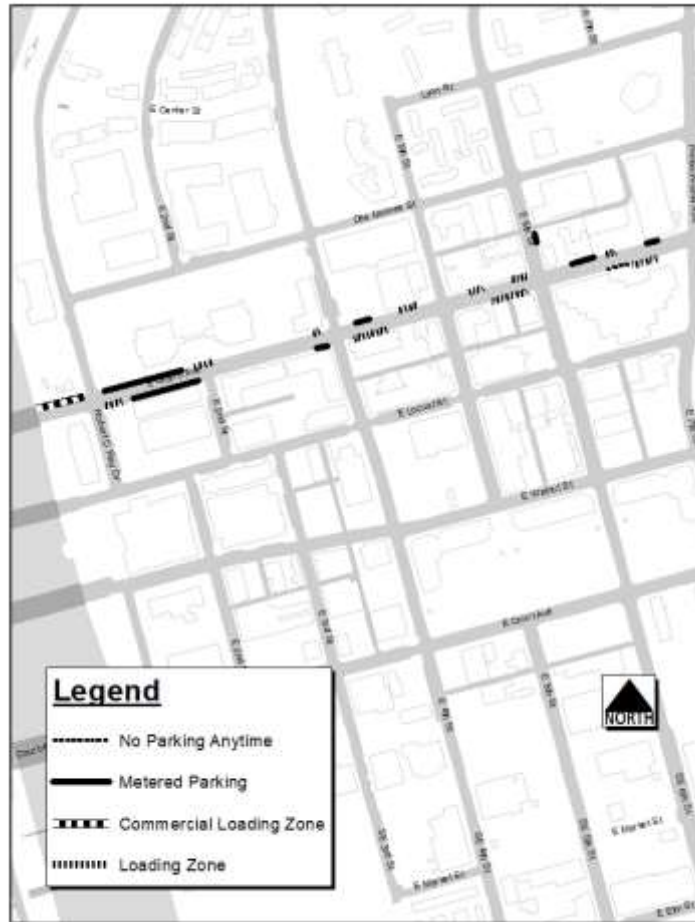

ADDITIONAL INFORMATION:

- A. As a part of the E Grand Avenue Resurfacing Project, E Grand Avenue was resurfaced from the Des Moines River to Pennsylvania Avenue. Sidewalk and curb bump outs were added at the intersections of Robert D Ray Drive, E 2nd Street, E 4th Street, E 5th Street, E 6th Street, and Pennsylvania Avenue along E Grand Avenue and at the intersection of Pennsylvania Avenue and Des Moines Street. Permanent durable pavement markings were added to designate travel and bike lanes with the project. The installation of the sidewalk and curb bump outs has necessitated revisions of the Municipal Code at various points along E Grand Avenue from Des Moines River to Pennsylvania Avenue, along Pennsylvania Avenue from E Grand Avenue to Des Moines Street, and along E 6th Street from E Grand Avenue to Des Moines Street to match the revised street geometry and curb lines at the various intersections.

Overall there will be a net increase in the number of on-street parking spaces with some handicap accessible spaces being relocated or removed and changed to regular spaces. Upon review of the existing Municipal Code for these street segments, the need for several corrections to the code were found to match field conditions in addition to the changes precipitated by the street improvement project. The parking permitted in the project area is

generally controlled with parking meters except for spaces on the west side of Pennsylvania Avenue between E Grand Avenue and Des Moines Street, which are not controlled by meters. The following modifications to the Municipal Code are necessary to reflect the changes resulting from the project.

Sec. 114-3271. East Grand Avenue—East Sixth Street to Pennsylvania Avenue.

East Grand Avenue, on the south side, from a point 176 feet east of East Sixth Street to a point 320 144 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from a point 320 feet east of East Sixth Street to a point ~~115~~ 130 feet east thereof, loading zone.

East Grand Avenue, on the south side, from a point ~~435~~ 450 feet east of East Sixth Street to Pennsylvania Avenue, no parking any time.

East Grand Avenue, on the north side, from a point 285 feet west of Pennsylvania Avenue to a point 50 feet west thereof, no parking any time.

~~East Grand Avenue, on the north side, from Pennsylvania Avenue to a point 96 feet west thereof, no parking any time.~~

~~East Grand Avenue, on the north side, from a point 190 feet west of Pennsylvania Avenue to a point 25 feet west thereof, commercial loading zone.~~

~~East Grand Avenue, on the north side, from a point 60 feet east of East Sixth Street to a point 30 feet east thereof, no parking any time.~~

~~East Grand Avenue, on the north side, from a point 90 feet east of East Sixth Street to a point 20 feet east thereof, loading zone.~~

Sec. 114-3565. Pennsylvania Avenue—East Locust Street to East University Avenue.

~~Pennsylvania Avenue, on the west side, from East Locust Street to Buchanan Street, no parking any time.~~

Pennsylvania Avenue, on the west side, from East Locust Street to East Grand Avenue, no parking any time.

Pennsylvania Avenue, on the west side, from Des Moines Street to Buchanan Street, no parking any time.

Sec. 114-2655. East Sixth Street—East Grand Avenue to Des Moines Street.

~~East Sixth Street, on the east side, from a point 60 feet north of East Grand Avenue to a point 50 feet north thereof, commercial loading zone.~~

- B. The revisions will allow the installation of three (3) additional metered parking spaces on the east side of SW 6th Street south Cherry Street. It also corrects the measurement of the parking restrictions on the east side of SW 6th Street from a point south of Cherry Street to West Martin Luther King Jr Parkway.



Sec. 114-2658. Southwest Sixth Street--Cherry Street to Army Post Road.
