AGENDA HEADING:

New Sections 26-904 and 26-905, relating to revised deadlines for submittal of energy and use benchmarking reports and exemptions.

SYNOPSIS:

Amends the Energy and Water Benchmarking Ordinance to revise benchmarking deadlines and other key dates based on evaluation of program improvements and required coordination with partner energy and water utilities.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

- On June 3, 2019 City Council approved adding and enacting Article IX. Energy and Water Use Benchmarking, relating to energy and water use benchmarking for certain properties in the City.
- Amends the ordinance under Sec. 26-904. Benchmarking Reporting Schedule, Part (b), to extend annual reporting deadlines for the preceding data reporting year to July 1st of each succeeding calendar year.
- Amends Sec. 26-904. Benchmarking Reporting Schedule, Part (d), to extend the date of publication for energy and water data to December 31st of each succeeding calendar year.
- Amends Sec. 26-905. Benchmarking Exemptions, Part (b) to extend the date from March 1st to May 1st for the annual exemption request deadline.
- These changes accommodate automatic data release dates identified by our partner utilities to property owners. It also provides additional time for program staff to evaluate, review, and resolve data accuracy and inaccuracies with reported data before publication for each reporting cycle.
