AGENDA HEADING:

Ordering construction of the following: 2021 Sanitary and Storm Sewer Televising Program -Receiving bids, (4-6-21), and Setting date of hearing, (5-10-21). Construction Estimate - \$495,280.

SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for the inspection of sanitary sewers throughout the City of Des Moines. This project includes video inspection, manhole inspection, and manhole location of the sanitary sewer system. This project is the start of a comprehensive program to examine the entire sanitary sewer system to determine preventive maintenance needs and future Capital Improvement Program (CIP) projects. This project focuses on the four (4) localized areas which account for approximately 10% of the entire sanitary sewer system.



ADDITIONAL INFORMATION:

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2021 Sanitary and Storm Sewer Televising Program, 07-2021-001. The project includes the inspection and televising of approximately 10 miles (430,000 lineal feet) of sanitary sewer pipe ranging in size from 6-inch to 60-inch diameter utilizing Closed Circuit Televising (CCTV), including miscellaneous associated work and cleanup located throughout the City of Des Moines, Iowa; all in accordance with the contract documents. The 2021 contract focuses mainly focuses on televising sanitary sewers, however, these areas will include televising a few locations of storm sewers.
- The estimated construction cost is \$495,280. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
