### **AGENDA HEADING:**

Approving the purchase of two (2) conventional cab heavy duty truck replacements with specialized asphalt rehabilitation and emergency snow and ice control equipment installed for use by the Street Maintenance Division of the Public Works Department.

#### **SYNOPSIS:**

Recommend approval to purchase two (2) conventional cab heavy truck chassis from Housby Mack Inc. (4747 NE 14th Street, Des Moines, IA 50313, Kelly Housby, CEO), in the amount of \$209,788.00, utilizing Sourcewell purchasing contract number 060920-MAK, with specialized asphalt rehabilitation and emergency snow and ice control equipment installed from Henderson Products Inc. (916 South 10th Street, Manchester, IA 52057, John Sievert, President), in the amount of \$550,552 utilizing Sourcewell contract numbers 080818-HPI and 052417-PBL for use by the Public Works Department.

#### **FISCAL IMPACT:**

Amount: \$760,340

Funding Source: 2021-2022 Operating Budget, Equipment Replacement Fund, Page 83.

#### ADDITIONAL INFORMATION:

- Two (2) existing heavy-duty trucks with permanently mounted asphalt patching equipment bodies and front snowplows meeting replacement criteria were approved for replacement by the Fleet Oversight Committee (FOC) as part of a 5-year replacement plan. The replacements will have enhanced emergency snow and ice control equipment including front, underbody, rear mounted wing plows and precision control material spreaders for liquid and granular salt application systems to further expand emergency snow and ice control capabilities.
- In addition to increased emergency snow and ice control equipment, portable asphalt patching drop in bodies are included for safe and rapid redeployment of asphalt patching capabilities during non-snow and ice control times and warm weather months operations.
- There are currently no full electric heavy-duty truck cab and chassis for these applications.
