AGENDA HEADING:

Hearing on 2021 Hot Mix Asphalt (HMA) Residential Paving Program Contract 2: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Grimes Asphalt and Paving Corporation, Timothy Mallicoat, President, \$543,484.

SYNOPSIS:

This is a public hearing to allow for public input on the 2021 HMA Residential Paving Program Contract 2 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the paving of residential streets utilizing surface scarification and HMA to pave the surface to extend the useful service life of the streets. The project also includes constructing Americans with Disabilities Act (ADA) compliant sidewalk curb ramps within the project areas.

FISCAL IMPACT:

Amount: \$543,484 construction contract (\$800,000 City Engineer's Estimate)



ADDITIONAL INFORMATION:

- On April 19, 2021, under Roll Call No. 21-0599, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2021 HMA Residential Paving Program Contract 2. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2021 HMA Residential Paving Program Contract 2, Activity ID 06-2021-003. The improvements include furnishing labor, equipment, and materials all in accordance with the contract documents, at the following locations all within the City of Des Moines:
 - 21st Street from University Avenue to Forest Avenue Removal of existing HMA pavement with milling/scarifying to an average depth of three (3) inches, preparing

subgrade/subbase, and paving three (3) inches of HMA pavement, manhole boxouts with Portland Cement Concrete (PCC), and replacing existing sidewalk ramps with ADA compliant sidewalk ramps.

- 45th Street from Chamberlain Avenue to Kingman Boulevard Removal of existing HMA pavement with milling/scarifying to an average depth of four (4) inches, preparing subgrade/subbase with cement stabilization, replacing sections of PCC curb and gutter, and paving four (4) inches of HMA pavement, manhole boxouts with PCC, and replacing existing sidewalk ramps with ADA compliant sidewalk ramps.
- o 45th Street from Kingman Boulevard to University Avenue Removal of existing HMA pavement with milling/scarifying to an average depth of four (4) inches, preparing subgrade/subbase with cement stabilization, constructing PCC beam curbs, and paving six (6) inches of HMA pavement, manhole boxouts with PCC, and replacing existing sidewalk ramps with ADA compliant sidewalk ramps.
- o 56th Street from Douglas Avenue to Madison Avenue Removal of existing HMA pavement with milling/scarifying an average depth of two (2) inches, replacing sections of PCC curb and gutter, and paving two (2) inches of HMA pavement.
- Sealed bids for said improvement were submitted by the following bidders:
 - o Grimes Asphalt and Paving Corporation, Des Moines, IA, Low Bid
 - o InRoads, LLC, Des Moines, IA
 - o OMG Midwest, Inc. d/b/a Des Moines Asphalt & Paving, Ankeny, IA
- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on May 11, 2021.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Grimes Asphalt and Paving Corporation (Timothy Mallicoat, President, 5550 NE 22nd Street, Des Moines, IA, 50313), in the amount of \$543,484, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
