AGENDA HEADING:

Hold hearing for approval of documents for vacation of a portion of Cohen Park located north of and adjoining 1106 Scott Avenue and approval of a land exchange agreement with Des Moines Climate Controlled Self Storage, LLC (DMCCSS).

SYNOPSIS:

Recommend approval of vacation of a portion of Cohen Park located north of and adjoining 1106 Scott Avenue and approval of a land exchange agreement with DMCCSS (Mark Bockenstedt, Owner, 1003 NW Ridge Road, Ankeny, Iowa 50023), subject to the reservation of an easement upon the City's parcel for the continued use and maintenance of any existing utilities now in place, and all terms and conditions of the land exchange agreement.


This equal land exchange will add programmable square footage and a more regular greenspace boundary to Cohen Park providing the City with additional land for expansion of Cohen Park to incorporate programming, use, and potential future park amenities. This action is required by Iowa law prior to making a final determination on the land exchange by resolution. The portion of Cohen Park to be vacated and conveyed will have no impact on the current or future use of the park.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

- The DMCCSS property at 1106 Scott Avenue shares its western boundary with Cohen Park. A portion of Cohen Park is also joined on two (2) sides by excess City property locally known as 503 Southeast 12th Street.
- DMCCSS has negotiated a purchase and development agreement with the City for the purchase and redevelopment of 503 Southeast 12th Street. DMCCSS has further offered to exchange 1106 Scott Avenue and a portion of adjoining vacated alley also owned by DMCCSS for an irregular shaped portion of Cohen Park that adjoins 503 Southeast 12th Street on two (2) sides. This exchange of land will help facilitate the redevelopment of 503 Southeast 12th Street while creating more useable space within Cohen Park to accommodate future park amenities.
- The parcels of land to be exchanged are equal in value, as determined by the City's Real Estate Division, and there will be no proceeds as part of this transaction.

• The Parks and Recreation Department and Real Estate Division of the Engineering Department recommend approval of this this equal land exchange resulting in more regular site boundary.
