### AGENDA HEADING:

Approval of amendment to agreement for the shared use and fees for golf badges at City of Des Moines Golf Courses, Jester Park Golf Course, and Terrace Hills Golf Course between City of Des Moines, Polk County Conservation Board, City of Altoona, C Corporation and CS Corporation.

### SYNOPSIS:

Recommend approving amendment to the agreement for the shared use and fees for golf badge changes at City of Des Moines golf courses, Jester Park Golf Course and Terrace Hills Golf Course between City of Des Moines, Polk County Conservation Board, City of Altoona, C Corporation, and CS Corporation.

### FISCAL IMPACT:

Amount: It is estimated that the proposed change will have minimal impacts to the revenue received by the City.

Funding Source: FY 2021-2022, Operating Budget, Golf Contracted Operations, E201 PK001201, page 173.

### ADDITIONAL INFORMATION:

- Under the golf management contract that has been in effect since January 15, 2010, the contractor, C Corporation, is responsible for proposing fee and badge changes for consideration by the City.
- On January 13, 2020, by Roll Call No. 20-0080, the badge agreement was expanded to include City of Altoona's Terrace Hills Golf Course, in addition to the three (3) City of Des Moines golf courses and Polk County Conservation Board's Jester Park Golf Course.
- Due to changes in ownership of the Terrace Hills Golf Course management contractor, CS Corporation, all parties to the current agreement concur to amend to remove Terrace Hills from the golf badge play locations.
- At the October 21, 2021 meeting of the Golf Advisory Committee, a subcommittee of the Parks and Recreation Board, the subcommittee members were made aware of these changes and are also understanding of the amendment to the agreement.
