AGENDA HEADING:

Approving agreement for Fleet Service Parts operation.

SYNOPSIS:

Approving a contract for the provision of on-site fleet services parts procurement, and supply services utilizing Sourcewell Purchasing contract number 110520-GPC with Genuine Parts Company (d/b/a NAPA Auto Parts {NAPA} Dennis Gibbs, Vice President, Midwest Division, 2222 East Douglas, Des Moines, Iowa 50305), to run concurrent with the Sourcewell contract through December 29, 2024.

Amount: \$3,000,000 annually, estimated.

ADDITIONAL INFORMATION:

• This new agreement contained terms and conditions for NAPA to provide parts at cost plus 7%; additionally, tires, tire service, fluids, lubricants, oils, coolants, shop supplies, and minor tools and equipment are provided at cost plus 5%. The agreement also caps annual operating and staffing costs for the term of the contract and limits operational expenses to the contractor's actual costs as shown below.

- NAPA has successfully provided parts procurement and supply services to the City since April 2006, under various contracts to provide all staffing and related services to Fleet Services for vehicle and equipment parts. NAPA was the successful proposer to an initial and subsequent Request For Proposal (RFP) solicitations. Over the course of the duration of previous RFP solicitations less responses were received at increasingly higher cost margins from other respondents. The resulting agreement recommended for approval has terms and conditions that are consistent with previous RFP awards and at lower costs that the base Sourcewell contract offering.
- Due to the long-term success of contracted parts operation with services from NAPA, staff recommends approving this new agreement for NAPA for parts procurement, on-site operations and related services using the Sourcewell contract options.
